Changes to the entries on the Depository Interest register after 6:00 p.m. (CET) on 20 February 2013 or, in the event that the Extraordinary General Meeting is adjourned, in the Depository Interest register 72 hours before the time of any adjourned meeting, shall be disregarded in determining the rights of any person to attend or vote at the Extraordinary General Meeting, notwithstanding any provisions in any enactment, the articles of association of the Company or other instrument to the contrary.
